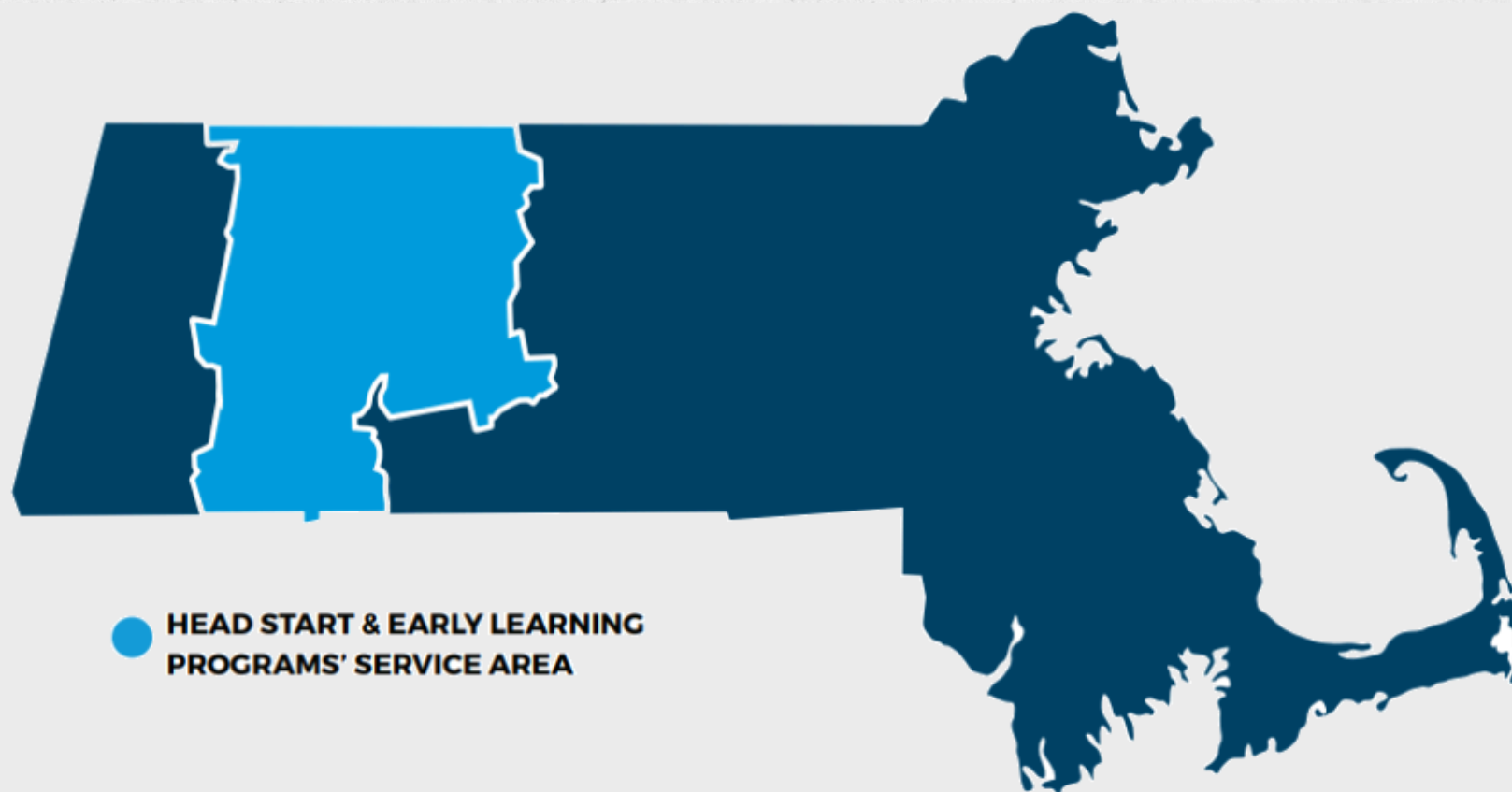

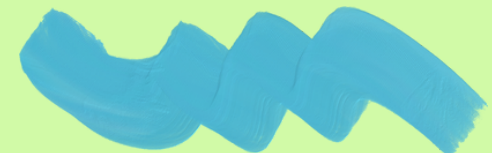

OUR STAFF

We employ over 130 dedicated staff with a wide range of professional and personal backgrounds who are passionate about working with you and your children! All employees go through an extensive background check process, and meet or exceed State and Federal qualifications in their area of expertise.

HS & ELP is a learning organization, and all of us participate in ongoing professional development to ensure that our work is supported by best practices in the field. We value our staff and know that we are stronger when we hear everyone's input, so we ask staff about their experiences and how they think we could make our services even better.

DID YOU KNOW?

Our staff rank the children and families they work with as a major reason they continue to work for Head Start.

15% of our staff were once Head Start parents just like you!



THINGS TO KNOW

1. We encourage you to dress your child ready-for-play! This includes weather-appropriate layers, secure shoes, and an extra set of clothes for messy art projects.
2. We have plenty of fun things to do in our program, so please leave your children's belongings at home so they don't get lost, stolen, or broken while in attendance.
3. No two children develop in the exact same way, and we screen all children's health and development. We ask for your consent, and you are always welcome to be present during the screening process!
4. No child is required to be toilet trained in order to receive services. You and your child's Educator will work together to understand your child's readiness.





5. Health and safety has always been one of our top priorities. Our program has developed effective health and safety protocols aligned with local, state, and national guidelines to ensure the health and wellness of all children, families, and staff and to minimize risks. Our staff will orient you to the most current protocols.

6. Head Start Educators and Family Advocates conduct home visits to set goals and get to know you. They also hold parent conferences to talk about your child's education. Speak with your classroom Educators about the best way to contact them if you ever want an additional meeting.

HEAD START: THEN & NOW

In 1964, President Lyndon B. Johnson declared “The War on Poverty” in his State of the Union Address. Head Start was launched the next year as one part of this initiative.

The program was designed to help break the cycle of poverty by providing education and comprehensive services to low-income families with preschoolers. One central tenet from the beginning was to establish programs that were culturally responsive and led in partnerships with parents to meet family and community needs. This is still very much true today.

Head Start has since expanded to include Early Head Start services as of 1995. The federal program now serves over 32 million children in all 50 states. Family engagement and leadership drives the direction of our program and ensures that we are responding to community needs.

We know from a growing body of research that parent and family engagement is crucial for all young children’s learning and development. By building strong relationships with children and their families, our staff are able to help children succeed in school.



ELIGIBILITY & ATTENDANCE

Children are eligible for Head Start or Early Head Start services:

- If their family meets the Federal Poverty Guidelines and/or receives public assistance (for example SNAP, DTA cash assistance, or SSI)
- If they are a foster child
- If they are homeless

Although most participants must be income-eligible, we can enroll some slightly over-income families as space allows. Head Start does not require citizenship for participation.

Once enrolled in the Program:

- An Early Head Start child remains eligible until moving into a Head Start program
- A Head Start child remains eligible for 2 program years
- Eligibility is reassessed as your child transitions or continues in the program.

Regular Attendance

Consistent attendance ensures that your child gets the maximum benefit from our program and helps prepare the whole family for kindergarten and a lifetime of learning.

If your child is going to be absent, you are required to contact your Educator or Family Advocate prior to your usual arrival time. If transported by bus, you must also call the bus cancellation line before the bus departs at 6:45 AM.

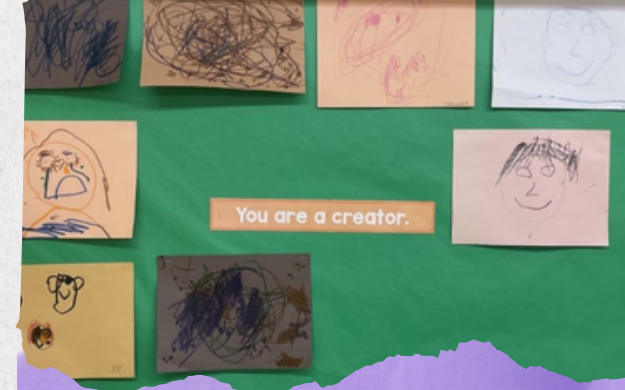
OUR SERVICES

Our Program Options

- **Part-Day/School-Year Head Start** (preschool) in centers in Franklin and Hampshire counties
- **Full-Day/Full-Year Early Head Start & Head Start** (infant, toddler, and preschool) in Amherst, Northampton, and Turners Falls
 - Funding from the Massachusetts Department of Early Education & Care (EEC) makes it possible for us to provide full-day services.
- **Extended-Day/School-Year Programs** for children birth to five in Westfield, and for preschoolers in Agawam and Orange
- **Head Start at Home** (Home Visiting) for expectant parents, infants, toddlers, and preschoolers in all counties

We work with you to meet your needs and to find the right option!

All program options include "comprehensive services." These services help you meet your goals for your family and for your child's development. A Family Advocate will be your partner in a long-term relationship with your family. We also have staff who support health, mental health, nutrition, and more.



*Everyone
is Welcome!*

We value diversity and are enriched by our differences! We welcome people from all backgrounds, family structures, and identities. Many families' first language is not English. There are many benefits to being bilingual, so we will work with you to keep your home language alive. Our staff will also work with you to incorporate elements of your family traditions while your child is in our care. Let us know ways we can do that!



HEAD START AT HOME

In our Home Visiting program, we offer weekly play-based learning activities in your home, which are tailored to your child's interests and needs. Your Head Start Home Visitor will partner with you as you care for your young child and will support you as your child's primary Educator. You will also have access to information, referral services, and opportunities to connect with other local families!



Services for Pregnant Women & Expectant Parents

- Head Start & Early Learning Programs Home Visitors partner with you and your family for you to learn more about pregnancy, parenting, and childbirth.
- Your Home Visitor will provide information or trainings based on your unique needs and questions.
- Your newborn can be automatically enrolled into our Early Head Start home-visiting program, and we will continue to provide postpartum support.





EARLY HEAD START

The first three years of life lay the foundation for all development, and we recognize the importance of high-quality care for the youngest children and families in our communities.

Early Head Start centers utilize a primary caregiver model, allowing the youngest children to develop attachments with our caring Educators. Infants and toddlers are supported to learn through play and build skills in the context of caring relationships and daily routines.

We embrace the many languages our families bring! We work to provide continued exposure to the home language as the best way to support children's language development.

As is true throughout our program, we see the parent as the child's first teacher and want to know what your caregiving preferences are. Our staff will help to make arrangements that keep you and your child comfortable and safe while you're at work or school.



- We care for infants starting at 6 weeks old
- We provide diapers, wipes, and formula
- We also fully support breastfeeding

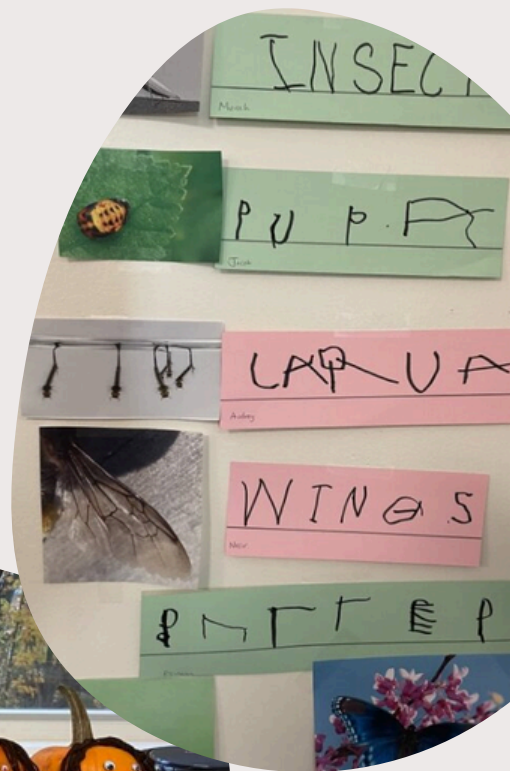
HEAD START

We work with families and the community so that children can develop caring relationships, confidence, and curiosity.

We operate many Head Start sites including large multi-classroom sites and one-classroom models. Our services for preschoolers are fun, engaging, and responsive to your family's cultures and needs.

We use the "Creative Curriculum," which provides a flexible framework for Educators to instruct children and ensure they are ready for kindergarten.

Children learn through play and hands-on experiences. The daily schedule consists of large and small group activities, time for imaginative, child-directed play, outdoor time and rich child-Educator interactions.



FAMILY WELL-BEING

In addition to our high-quality learning environments, we also provide a wide array of **Comprehensive Services**.

This includes (but is not limited to):

- Health and nutritional screenings
- Dental referrals
- Meals and snacks
- Resources for parents as learners
- Mental health support
- Developmental services and special education support
- Leadership and volunteer opportunities
- Referrals and family advocacy
- Transportation (as available)

As our mission statement indicates, family engagement is at the heart of what we all do. In Head Start, we pride ourselves in partnering with all families and responding to the unique needs of our community.



HEALTH

Good health is the necessary foundation for children to feel safe, attend consistently, and be ready to learn.

Our Specialists partner with families to provide health information, screenings, and access to medical care.

Children need immunizations, physicals, and dental exams to be accepted into the program and are expected to remain up to date. We additionally support families in getting connected with reliable, consistent, and accessible dental, medical, and mental health services as needed.

NUTRITION

With funding from the USDA's Child and Adult Care Food Program, our program provides healthy, well-balanced meals and snacks. We work with families to develop diet modifications for any child with food allergies, intolerances, or restrictions.

DEVELOPMENTAL SERVICES

We want to partner with you to work with your child and we know that you are your child's best advocate.

Serving all children in an inclusive environment is at the core of the mission of Head Start. Our multi-disciplinary team works closely with families to support each child's individual needs. Children with developmental delays, disabilities, or other special needs are welcome in all our programs.

We have close partnerships with many community service agencies, and we can help you get connected to appropriate services for your child's time in our program and beyond.



FAMILIES AS ADVOCATES & LEADERS

Parents who take on leadership roles change their community and the lives of their children and themselves for the better. Your contributions, big or small, make a big difference for our program! There are so many opportunities for you to be a bigger part of our program depending on your schedule and desire.

Each center and Home Visitor facilitates **Family Meetings** where you can participate in local leadership as part of the parent committee and discuss what's important to you.

Each parent committee also elects a **Policy Council** representative to participate in program governance and to vote on important decisions, like hiring staff, applying for grants, and how to use fundraising money.

We have **advisory committees** and **self-assessment focus groups** that require as little as 1-3 meetings yearly where you can help us in our long-term planning or discuss specific topics affecting the community, like health, oral health care, disabilities, or social services.

If meetings aren't for you, then you can still participate by attending field trips and special activities with your child!



FAMILIES AS LEARNERS

Each year, we offer a number of opportunities for family members to join our **Touchpoints™ Parent Groups**! Parent Groups are a supportive environment for parents to partner with other parents as you navigate your family's unique journey.

Each session will provide you with opportunities and tools to:

- better understand and guide your child's development
- help with challenging times or confusing behaviors
- remain close and connected and have fun with your child
- develop connections with other families

The **Touchpoints Parenting Curriculum** is research-based and focuses on the strengths of children & families. Over the course of 5 sessions, we will partner with you to explore:

- The Joys and Challenges of Parenting Your Unique Child
- Understanding Your Child's Development
- Your Family's Culture and Language
- Nurturing and Caring for Your Children
- Discipline: Your Role as Parents Over Time

Ask your Family Advocate, Home Visitor, or Educator about how to join!

FAMILIES AS EDUCATORS

Volunteers do not earn money, but their donated time helps us with local matching funds for our federal funding. **When you volunteer, we count your time as a donation!**

1 hour of volunteer time: \$22.91

2 hours attending a family meeting: \$77.86

1 month with 1 hour a week of suggested learning activities with your child: \$91.64

1 hour as a Policy Council Representative: \$68.22
